

#### History that tells the story of the financial transformation of the Connellsville Area School District

Year 1 /2	2015-16 Budget Cycle
April 15, 2015	Philip Martell begins tenure as Business Manager
May 1, 2015	Determined that district had an actual deficit of \$5-7 Million.  Developed Financial Recovery Plan for the Connellsville Area School District for the next three years.
May 15, 2015	Prepared/Passed Preliminary budget with a \$4.9 million expenditure to revenue deficit.
June 12, 2015	Board passed action to volunteer to PDE for Financial Recovery Act and full transparency with public and department.
June 30, 2015	Passed final balanced budget with PDE and reduced the budget expenses by \$4.9 Million. Projected Fund Balance Deficit from 2014-15(prior to arrival) of \$2.1 Million and submitted to PDE.
June 30, 2016	Balanced Budget Passed and District Continues downsizing expenses.
Sept-Dec 2016	Feasibility Meetings started and Town Hall Forums conducted.




